"How do others see Christ in me?"

JESUS asks us each and every one, "Who do you say I am?" The highest ranking Roman official in Jerusalem, whose main job was to discover what's true and make judgments, had such a low opinion of truth that when he discovered JESUS was not guilty of any charges, he still ordered JESUS to be treated and executed as if HE was a most dangerous criminal. Read John 18:28-19:16 and think. JESUS told Pilate HE was born to confirm the existence of truth and that anyone on the side of truth listens to HIM. Pilate could not hear that, partly because of his low opinion of truth and partly because he thought JESUS was just another man subject to Pilate's judgement.
